### **GENERAL CLEANING**

Offices, Entrances, Reception Areas, Meeting Rooms, Classrooms, Hallways, Common Areas, Restrooms, Stairwells, Floor Care

### To Be Cleaned Monday – Friday

- Empty all wastepaper receptacles
- · Replace waste receptacle liners as need
- Disinfect light switches, light switch plate covers, and door handles
- Clean 9 restrooms throughout the facility
- Clean and disinfect 3 water fountains
- Vacuum and empty trash in Main Office wipe down and disinfect phones & door handles, and window
- Vacuum and empty trash in 10 classrooms- six in the main building and four in the portables
- Downstairs lobby area vacuum carpet and clean/disinfect doors
- Spot clean activity room as needed
- Spot clean horizontal surfaces

- Entrance doors and internal glass partitions cleaned of fingerprints and smudges
- Vacuum, sweep or dust mop all hard surface floors
- Vacuum all carpeted traffic areas
- Mop all hard surface floors
- Wall-to-wall vacuuming of carpeted areas
- Remove spots and small spills from carper
- Disinfect All touchpoints with CDC Approved Disinfectant including handrails, door handles, light switches, horizontal counter tops, etc.

### **Restrooms - To Be Cleaned Monday - Friday**

- Clean and disinfect counter tops, wash basins, toilets, toilet seats, and urinals
- Clean and disinfect all dispenser, fixture and mirrors
- Empty Trash receptacles
- Empty sanitary napkin receptacle and disinfect
- Spot clean partitions and tile walls
- Restock hand soap and paper products
- Disinfect partition handles, door handles, and light switches
- Clean and sanitize outsides of dispensers and trash receptacles
- Polish all dispenser, fixtures and mirrors
- Sweep and thoroughly mop floor with germicidal solution
- High dust tops of partitions, air vents, mirror frames and tops of doors (Once a Week)

## To Be Cleaned Wednesday and Friday

- Both front lobbies on upper level cleaned and trash emptied
- Spot vacuuming of carpeted areas in the main building upstairs

### To Be Cleaned Once a Week

- Vacuum two stairs between top and bottom floors and wipe rails –Friday
- Mop floor outside classrooms in portables Friday
- Walls cleaned of fingerprints and smudges
- Dust air vents, tops of doors, door frames, ceiling corners

### To Be Cleaned Once a Month

- Detail vacuum carpet edges and corners along walls and partitions
- Dust all baseboards
